SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Acute toxicity, oral (Category 5). May be harmful if swallowed (H303).

SECTION 4 — FIRST AID MEASURES

If swallowed: Rinse mouth. Do NOT induce vomiting (P301+P330+P331).

Very deliquescent. Store in a cool, dry place within a Flinn Chem-Saf™ bag.
